# MINUTES OF THE BLACKWOOD TOWN COUNCIL MEETING HELD ON 4<sup>TH</sup>. MARCH 2024

#### 1. Apologies for Absence

Apologies for Absence were received from Cllrs. K Jones, R Mills , A Farina-Childs, N Dix & D Davies

## 2. Co-option P Cook - Acceptance of Office

The Mayor welcomed Cllr. P Cook to the meeting, and she duly signed the Acceptance Of Office, witnessed by the Clerk

### 3. Declarations of Interest

No Declarations of Interest were made at this point

## 4. Police Report

The Mayor welcomed PCSO Adrian Popa to the meeting which would be his last before starting his training to become a P.C.

The Officer reported that there were signs that ASB was reducing generally in the area, and that there were less instances at the bus station in particular of late, with thankfully no re-occurrence of graffiti in the area.

There had been, however, a spate of thefts from properties in the Cefn Fforest area, and also theft from a vehicle.

Parking on the High Street was still an issue, albeit with the positioning of the bollards, there were obviously improvements in some locations. He stated that when PCSO's are retrained in September, they will then be able to attend and issue traffic related fines for obstruction.

The Mayor & Cllr. K Etheridge formally thanked Adrian on behalf of Town Council for his dedication, co-operation and hard work over the past few years, with his proactive approach to tackling ASB he had had a very positive impact in the area, and would be sadly missed. He was wished well for his future in the force. These sentiments were echoed by all members present.

Adrian in turn thanked members for their support over the years, and hoped things would continue to improve and would maybe re-assigned to the town in the future.

#### 5. County Borough Report

Cllr. K Etheridge gave a brief update on some of the current issues affecting the town, namely –

Apollo Way School, where a petition is circulating that asks Caerphilly C.B.C. to reconsider their traffic management criteria to ensure school crossing patrol returns to the site, fearing for the safety of the pupils.

Blackwood Town Cricket club have made application for a variation of their Club Premises Certificate that will allow an increase to the area where alcohol can be consumed on the premises to the extents of the boundary of the club grounds ( to include an outside area )

Meetings with residents regarding proposed closure of Mayhill Bungalows Access Lane to enable drainage and carriageway improvements leading to Pobl development

Tenders for the Skateboard Park at the Showfield have now been issued by C.C.B.C. together with a provisional timetable with work on site planned to start early September with completion late October

Ongoing issues at Cwmgelli with liability acknowledged by C.C.B.C., it is now up to the residents as to whether they push or a private prosecution

Still nothing further to report on the planned Persimmon Development at Grove Park

The formal planning application in respect of the planned development on the Somerfield Car Park Site is now anticipated by the end of March, with several of the points raised during meetings with the developers likely to be taken on board.

#### 6. Mayoral Announcements

The Mayor reported he had attended the Sight Cymru first anniversary celebrations recently where their Chief Executive, the Rt. Hon The Lord Mayor of Cardiff, Cllr. Bablin Molik was also in attendance .

He also reminded members of the Blackwood Stakeholders Meeting scheduled for 6.00pm. Wednesday 13<sup>th</sup>. March at Blackwood Miners Institute and urged attendance if at all possible.

The Mayor also urged members to complete their DSB checks, and reminded them the Spring Fair was scheduled for Saturday 13<sup>th</sup>. April, albeit Town Council had no input on the day.

#### 12. Matters Arising

(a) Recommendation that Standing Orders Standing Orders/Financial Regulations be suspended and that the quote from Howden's for Kitchen be accepted and an order placed.

## 12. Verbal Update on Office Accommodation

The Clerk reported that he had received notification that the Council's offer of our Office on Gravel Lane as the Barclays Bank Local hub was unlikely to be accepted, albeit no formal statement could yet be made.

Several members commented on a recent cryptic message on the Libanus Lifestyle Centre Facebook page relating to some exciting news they had just received and thanking County Cllrs Andrew Farina-Childs and Nigel Dix together with the Cabinet Member Cllr. Jamie Pritchard for their support and help.

The Mayor reported he had approached both members regarding this post, and neither denied they had assisted Libanus in making an approach to Barclays Bank.

All members present voiced their disappointment that neither member had the courtesy to inform Town Council they were backing, what was in effect, a rival bid for Barclays Bank to occupy our Offices on Gravel Lane, knowing the time and effort by the Clerk & Mayor in trying to secure same.

After some further discussion, it was agreed we continue to reach out to other organisations who have expressed an interest in utilising our Offices, whilst also approaching H.S.B.C. to see if they might be interested in relocating.
